



CORPORATE BACKGROUND SCREENING CONSENT FORM

I agree that the Data Controller and the Data Processor and their respective employees and agents shall be released from and held harmless against any liability arising from the processing and the use of any personal data received from such parties in making an employment decision regarding me. I understand that the Data Controller may rely on this authorisation to order additional background reports, including investigative consumer reports, during my employment without asking me further for my authorisation as allowed by law.

I further acknowledge that any verification, screening or investigative report conducted by the Data Processor is based on information provided by me and/or obtained from third parties. I agree that the Data Processor and its employees and agents shall be released from and held harmless against any liability arising from the results of such screening or report and acknowledge that the reliability, accuracy and completeness of any report depend on the veracity and completeness of the information provided by me.

I agree that a copy of this form shall be treated as valid and enforceable as the original. I certify that all the personal information I provided is true and correct. I understand that misrepresentation or omission will constitute sufficient ground for rejection or for subsequent dismissal if I am hired.
